#### **Discussions and Subcommittee Reports**

- Development Tim Windemuth
  - \$284,000 debt pledges
  - \$103,000 pledges towards finishing classrooms
- Accreditation Doug Zimmerman
  - Standards for Accreditation several disclosures regarding our opening report for the beginning of the school year include several dings on our report: our physical education teacher is not credentialed. His degree is in graphic design. The other ding is that one of our teachers' credentials has expired and they are in the process of working on taking care of this.
- Loan Refinancing Alexander Nickolatos
  - Voted to approve the refinance of two NPUC revolving fund loans with three lenders at 2.5% and a ten-year amortization with a balloon payment at the end of seven years. Approved the use of \$50,000 from operating funds to pay down the largest loan prior to refinance.
- Subcommittee Updates:

Building Committee – gave an update on the roof repairs from storm damage. Both the church and the school will have a new roof for less money than expected. The roof repairs will likely take place in the Spring 2022 due to the high volume of work contractors are facing.
